

SUBJECT: Upcoming Vacancies for the Healthy Families Program Advisory Panel Meeting

The Managed Risk Medical Insurance Board (MRMIB) is seeking applications for individuals to fill the upcoming vacancies on the Healthy Families Program (HFP) Advisory Panel to advise the Board on policies, regulations, operation, and implementation of the HFP. The HFP is a state and federal subsidized children's health, dental, and vision insurance program for children in low to moderate-income families. The program was implemented on July 1, 1998, and is currently insuring approximately 900,000 children.

The Advisory Panel is comprised of 15 members who serve three-year staggered terms on a voluntary basis. They are compensated for necessary travel expenses. In addition, Advisory Panel members representing subscribers are provided with compensation of \$100.00 per meeting. The Advisory Panel meets quarterly and the meetings are usually from 10:00 a.m. to 1:30 p.m. in West Sacramento. The next scheduled meeting is Tuesday, May 11, 2010, in West Sacramento. MRMIB is seeking representatives for the following four categories:

1. 1 HFP Subscriber Representative
2. 1 Representative from a Family Practice Physician
3. 1 Disproportionate Share Hospital Representative
4. 1 County Public Health Representative
