### Results To-Date



As of August 2008, there are 20,337 active Certified Application Assistants (CAAs) statewide, 202 CAAs became active in August 2008 in comparison to 213 that became active in July 2008.



As of August 2008, there are 3,188 active Enrollment Entities (EEs) statewide, 68 EEs became active in August 2008 in comparison to 61 that became active in July 2008.



Approximately 4,175 new CAAs were trained through the online web-based training (WBT) program from February 2005 through August 2008; 140 CAAs passed the WBT in August 2008 in comparison to 165 that passed in July 2008.
